Norwood Pikitup Depot Closed

Two staff members at the Norwood Depot have tested positive for Covid. As a result the Depot will be closed for the next two weeks. Weekly clearing of bins (RCR) will still be operational.

Pretoria Street Bridge Park - Committee Lead: Trevor Lunt

Illegal dumping in the park bordered by Pretoria Street and Hilson Street (between Oaklands and Highlands North Extension) has unfortunately increased. Trevor Lunt has led a number of clean ups in his personal capacity, which NORA has supplemented with volunteer clean up days, but we have unfortunately come to the conclusion that we need to restrict all but pedestrian access to the Park. Fencing the park will cost in the region of R70,000, and NORA has committed to covering R10,000 through existing reserves. Shothole Borer Beetle - Committee Lead: Cindy Meltzer

In this time of Lockdown Level 4 perhaps you have taken to our tree-lined streets to exercise and have noticed the state of our trees. Most of the London Plane and Oak trees that line the pavements have been infected by Polyphagous Shot Hole Borer (PSHB), but many of the indigenous trees seem healthy.

Dr Wilhelm de Beer of FABI has stated that the most effective way to fight this beetle is through management. To this end we would like to establish an inventory of pavement trees to identify those infested by the borer and would like to work with City Parks to address the problem. Dead trees have to be removed by City Parks and properly disposed of.

As you walk, perhaps you could note which trees seem affected and send us a pic or description to Cindy on cmeltzer@mweb.co.za

It is up to residents whether they will remove or treat trees on their properties. Treatments by Arborists is available under level 4. You can help affected trees by removing stress factors aggravating infestation including proper watering, mulching and protecting root base, checking for of other diseases, root or stem damage and removing competing vegetation surrounding the tree.

City of Johannesburg Development Planning are slowly opening up services, and we will soon know the way forward. Recycling – Committee Lead: Nadine Hocter

There has never been a more important time to recycle. Understanding the recycling symbols on waste will help you decide what can be recycled. All plastic is numbered with a little symbol on the bottom of the container. There are 7 in total:

- #1 PET: When recycled PET plastic bottles are turned into many new and useful products. PET is too valuable to be thrown away so please be sure to recycle these if nothing else!
- #2 HDPE: High-density polyethylene (HDPE) is used for bottles, crates and drums, and is easily recycled.

- #3 PVC: is toxic and not easily recycled. Avoid purchasing.
- #4 LDPE: is commonly used in plastic bags and is not easily recycled. Avoid purchasing.
- #5 PP: This makes up stiff thin-walled packaging items. Can be recycled, but generally isn't. Avoid purchasing.
- #6 Polystyrene: AVOID!
- #7 Other: a catch-all for polycarbonate (PC) and "other" plastics. AVOID!

Now that waste recyclers are again working, here are a couple of tips to make their lives easier:

HOW YOU CAN HELP RECLAIMERS

SEPARATE RECYCLABLES

Put your recyclables in a separate bag for reclaimers and dispose of any contaminated materials (tissues etc) in a clear, sealed bag so that reclaimers don't touch them. Please store your recyclables for 24 hours or disinfect them before you put them out.

WATER AND SOAP

Please consider leaving a solution of water and bleach, or soap and hand-sanitising products outside your house or near your collection point for reclaimers to wash their hands.

DONATE WHAT YOU CAN

Support reclaimers in your community with food, sanitiser, gloves or masks. The African Reclaimers Organisation has started a fund to raise money for food and supplies. Every bit helps.
